



Message from the Chairman



The start of 2023-2024 was characterized by financial uncertainty because Fondation Musicaction had to deal with both a drop of its revenues and with not knowing whether Canadian Heritage would renew for the coming years the additional regular funding that it had initially granted in 2019-2020. But good news at the end of the year helped clear away some of this financial uncertainty.

In light of these financial constraints, Musicaction implemented in early 2023-2024 budget cuts in all its programs while also making sure that sufficient funds would be available in an effort to limit the negative impacts of these cuts on its various clienteles. As the year continued, the stronger than anticipated recovery of the music industry recovery forewarned an overrun of the already restricted budgets. During the first half of 2023-2024, a very high number of applications were received in respect of both the national and international markets. Additional measures were thus put in place to contain this unforeseen budget overrun and maintain leeway for coming years given the financial unknown.

A first clearing of the skies and a major step for the Canadian francophone minority musical industry occurred at the end of 2023 when Canadian Heritage gave the Fondation a new mandate to fortify the capacities of the music infrastructure within that community. This additional funding of \$5M over five years was granted as part of the *Action Plan for Official Languages 2023-2028* and is behind the new Musicaction program *Support music entrepreneurs and organizations within francophone OLMCs*. This program was created through close collaboration with various stakeholders of that sector and was successfully launched in January 2024.

Significant improvements occurred later on, towards the end of 2023-2024, when, among other things, Canadian Heritage granted ad hoc additional funding of about \$2,9M for the same year. This allowed to accept, ahead of 2024-2025, projects related to diversity and to eliminate completely the expected deficit. Other good news followed, that is the long-awaited renewal of additional regular funding for 2024-2025 and 2025-2026 and the granting of a new amount of \$2,4M to face inflation for the same two years. Musicaction thanks Canadian Heritage for this and considers it a show of confidence and a recognition of its hard work to meet the needs of the music industry.

The Canadian Radio-Television and Telecommunications Commission (CRTC) also started during our financial year 2023-2024 its process to implement the Online Streaming Act which came into force on April 27, 2023. To be able to do more to support the development and discoverability of Canadian

and Indigenous musical content, Musicaction filed an intervention within Broadcasting Notice of Consultation CRTC 2023-138, The Path Forward – Working towards a modernized regulatory framework regarding contributions to support Canadian and Indigenous content.

Musicaction will celebrate 40 years at the beginning of the fall season in 2025-2026. Musicaction never stops to move forward and continues to undertake several important projects, such as compliance with new obligations regarding data privacy protection or actions to take before implementing a new integrated management system, while still working on continuously improving its programs to make them more inclusive and better adapted to the realities of its sector. As Chairman of the Board, I am proud of all that was accomplished in 2023-2024, and I know that the Fondation is thriving and ready to meet all the new challenges to come.

Message from the Chief Executive Officer



Providing support to all our clienteles in the carrying out of their projects is at the heart of the COMMITMENT made by Musicaction.

2023-2024 started with uncertainty in the air, but our team members were able to constantly find strength in the Musicaction Commitment value to mobilize for the clienteles throughout the year. Despite the financial unknown, the team's motto was to do all it could to continue to positively contribute to the music sector, to provide even more support in a multitude of ways.

Our commitment is first reflected in a program budget that is as close as possible to that of 2022-2023 despite a significant decrease in revenues. The Fondation was able to achieve this by drawing from its own funds, thus taking a calculated risk allowed by its sensible financial management over the last few years. However, a stronger than expected demand during the year forced the introduction, in some programs, of new restrictive measures to contain expenses. Difficult but targeted choices were made with the intent to limit as much as possible their impact on the affected clienteles.

The Fondation's commitment is also reflected in its implementation of new measures and practical actions for equity deserving groups. Therefore, two new important initiatives were instituted in 2023-2024, inspired by the *Étude sur les femmes dans l'industrie musicale canadienne francophone* published in March 2022, i.e. a new equity measure was added for female performers in the sound recording production programs and a new project was started, *Crescendo*, to allow professional starting their career to benefit from a transfer of knowledge and experience by being accompanied by recognized expert female entrepreneurs. *Crescendo* was organized in collaboration with *shesaid.so Montréal* and created and carried out by our *Collective Initiatives* team. The feedback and results of this project for women and people of the gender diversity were so positive that it was renewed for a second year.

A similar equity measure was introduced for Indigenous artists in juried sound recording programs. As a direct result of the 2021-2022 program supporting Indigenous entrepreneurship, a record number of applications were received for Indigenous performing artists for the fall 2023 juried programs. As well, the Fondation was proud to showcase Indigenous artists during the *Côte à Côte* event that was part of the significant *BIS de Nantes* show marketplace in France in January 2024.

At the end of the year, the whole team came together and worked hard to distribute within a very short time frame new funds from two additional ad hoc amounts awarded by Canadian Heritage. These funds were used, among others, to advance our commitment to provide more and better support to racialized communities.

Finally, our commitment to our clienteles shone through our fast and agile shaping, in collaboration with francophone minority communities, of a brand-new program *Support music entrepreneurs and organizations operating within francophone OMLCs*. New ways of doing things were put in place before and after the applications were filed, such as simplified forms or customized assistance for each applicant.

Because of the financial improvement at the end of 2023-2024, the future looks brighter for enhanced support of all forms of expressions of Canadian Francophone and Indigenous music. Much is still left to do. We will continue on this path with a view to collaboration and inclusion.





EFFENDI RECORDS – 25 years of jazz

A CATALYST FOR MUSIC CREATION WITHIN THE WORLD OF QUÉBEC JAZZ

Effendi Records has been there to help Quebec Jazz shine for a quarter-century. By publishing albums, producing concerts and tours, it has propelled the careers of a diversity of homegrown jazz artists.

Founded in 1999 by Carole Therrien and Alain Bédard, Effendi Records is now one of the most important jazz labels in Canada. From François Bourassa to Christine Jensen, as well as the Jazzlab Orchestra and the Auguste quartet, to name a few, this artist incubator has led to a multitude of awards, such as FÉLIX, JUNOs, ECMAs and Django d'Or.

Musicaction has supported the projects of **Effendi Records** for over 20 years via several of its programs, such as National Marketing, International Marketing or Album Production.



IN LOVE WITH QUEBEC AND ITS ARTISTS

Known as the father of the Quebec show business, **Guy Latraverse** was also one of the founders of the *Association québécoise de l'industrie du disque, du spectacle et de la vidéo* (ADISQ), of the *Francofolies de Montréal* festival, and he was also involved in all the televised galas created to recognize the artists and artisans of Quebec culture, from music to movies, to theatre and comedy. As a daring producer, he took care of the careers of Robert Charlebois, Claude Léveillée, Diane Dufresne, Louise Forestier, Yvon Deschamps, Jean-Pierre Ferland, as well as many others.

He produced *L'OSSTIDCHO*, A MYTHICAL SHOW

still alive in the collective memories of Quebeckers, which included Yvon Deschamps, Robert Charlebois, Louise Forestier and Mouffe, and also the Quatuor de jazz libre du Québec.

He produced the *1 FOIS 5* **SHOW** with Yvon Deschamps,
Claude Léveillée, Gilles Vigneault,
Jean-Pierre Ferland and Robert
Charlebois.

He founded with others the ASSOCIATION QUÉBÉCOISE DE L'INDUSTRIE DU DISQUE, DU SPECTACLE ET DE LA VIDÉO (ADISQ) to promote the music industry in Quebec.

EXPORT MISSION IN FRANCE TO SUPPORT PROFESSIONAL DEVELOPMENT

In 2023, the MaMA Festival et Convention in Paris proposed a « Focus Canada » series of events, in collaboration with Ma Cabane à Paname, to which several Canadian professionals participated. This transatlantic collaboration highlighted Canadian artistic diversity by bringing together 15 talented artists from British Columbia, Ontario, Quebec and Nova Scotia to perform in various showcases during the 3 days of the festival, from October 11 to 13, 2023.

In association with the Chambre syndicale de l'édition musicale (CSDEM), two different paths were offered: a writing camp for **songwriters and composers**, and various conferences and professional meetings **for publishers**.

The participants to the writing camp were divided in four teams of three each, and collaborations were varied every day, to further the creation of new musical works mixing French-language and Canadian influences. The writing camp ended with a listening session where the 12 works created were performed for the public.

The path for the 12 songwriters and composers sought to give them a unique creative opportunity to work in a studio of the Artistic Palace from October 8th to 10th.

The path followed by the 11 publishers sought to give them the opportunity to make business deals, to get a better understanding of the European territory and to participate, among others, to a panel on cowriting as an export tool.







ONE OF THE MOST INFLUENTIAL EMERGING ARTISTS OF HIS GENERATION WITHIN THE CANADIAN FRANCOPHONE MUSIC SCENE

In 2022, **Étienne Fletcher**, a Fransaskois singer, songwriter and composer based out of Regina, Saskatchewan won the Francophone Artist of the Year award at the Western Canadian Music Awards, just like Alexis Normand, Mario Lepage and Annette Campagne did before him. This recognition continued to resonate during the following year as he went on to win other awards and tour throughout the country.

Étienne made his album shine everywhere he went, from the Festival international de la chanson de Granby where he won the Tournée Granby-Europe award that allowed him to do a European tour, to Contact Ontarois or to RIDEAU. He won 4 Trille Or awards in 2023, including those for Artist of year and Album of the year. He went on several tours, including 15 shows in Quebec, performing among others at the Théâtre du Petit Champlain, the Théâtre Outremont, the Salle Georges-Codling, the Grand Théâtre de Québec, as well as several shows in Francophone Canada: Nuit émergente in Sudbury, Festival du Voyageur in Winnipeg, and many shows in Saskatchewan schools.

2024 is to be a songwriting year for Étienne Fletcher, whose creations will surely be inspired by all his touring memories.

SONGWRITER-COMPOSER, PRODUCER, BEATMAKER

As she did during her rock days in the band Hôtel Morphée and in the pop sound of her first solo album, XO (2016), Laurence Nerbonne continued to explore hip hop, trap and R&B in her albums Feu (2019) and OMG (2021). This songwriter, composer, singer, beatmaker and producer has a classical music background, and she mixes all these sounds brilliantly as she navigates various projects, such as producing the theme song of Star Académie 2021 with Marie-Élaine Thibault, the score for *Niagara*, the movie by Guillaume Lambert, and music for the *Pas de chicane dans* ma cabane movie by Sandrine Brodeur-Desrosiers.

Laurence Nerbonne came back in full force in 2024 with her fourth album, LE CIEL EST BEAU REGARDE LES NUAGES, which quickly reached number 1 of francophones sales in Québec.

This pop album, written, arranged and produced by Laurence Nerbonne, includes Cowgirl, a track by Mitsou, Nerbonne herself and Marie-Élaine Thibault, which acts as a hymn for female power and a nod to the successful Mitsou song, Bye Bye mon cowboy. The place of women in music is a central concern for Laurence, who does not hesitate to say and sing her feminism.

As the first Indigenous woman to win the Francouvertes, a competition showcasing emerging artists, 2024 shines a well-deserved spotlight on **Soleil Launière**.

After radiant collaborations with the bands CHANCES and Tarwa N-Tiniri, **Soleil Launière** presented a first album called Taueu, which means "in the middle" in Innu-amun, where she proposes a deep, skillful and delicate foray into her universe. She gives a prominent place to Joséphine Bacon, who brings about an atmosphere of contemplation, spirituality and poetry.

This soul-roots album, mixing pop sounds and magnetic arrangements, includes songs in the French, English and Innuaimun languages, as well as in a language of Soleil's own invention, all of which were brought together as part of a cultural identity reappropriation process.

Like her voice and stage performances, her sensitive and powerful presence leaves no one indifferent.


For the year ended March 31, 2024, Musicaction recorded revenues of \$22,469,534.

FINANCIAL CONTRIBUTIONS

The Foundation paid out \$19,926,930 in financial aid. The aid generally consisted of initial payments for projects accepted during the current year and final payments for projects accepted previously.

OTHER EXPENDITURES

For the year ended March 31, 2024, Musicaction's administration costs and amortization of capital and intangible assets amounted to 10.1% of total revenues, compared with 8.1% in 2022-2023.






COMPREHENSIVE FUNDING ENVELOPE

For the past four years, this program has been one of the pillars of the modernization of the Canada Music Fund (CMF). It promotes a revenueand investment-based business financing model. Financial assistance is awarded once a year to support activities that foster the career development of Canadian artists and the promotion of their music. The program covers expenses related to the production and marketing of sound recordings, national and international music tours and showcases, music publishing, artist management and business development activities.

Contributions to companies are awarded on a competitive basis, based on their ability to promote and develop audiences for Canadian artists, as well as to develop their careers. Companies must meet certain conditions to be eligible for this program.

In 2023-2024, the maximum amount granted was \$575,000 per individual company, and the total annual amount could not to exceed \$768,000 for companies part of an affiliated group. Up to 50% of costs were eligible.


This program is intended to support production of sound recordings. The album must have a minimum of six tracks (of at least 60 seconds each) or 20 minutes of musical content.

The applicant must be the owner of the master tape.

Albums accepted in 2023-2024 benefited from an exceptional measure, with maximum funding of up to 75% of accepted costs, or actual eligible costs, whichever was lower. Maximum funding could reach up to \$28,000 for French-language vocal music and world music, and up to \$23,000 for other music.

Contributions were granted to Canadian songwriters and composers of an album or digital titles funded for production by Musicaction.

Companies benefiting from a Comprehensive Funding Envelope under the Individual Initiatives Component are not eligible to this program.





With this program, Fondation Musicaction wishes to encourage the creation of an original repertoire as well as collaboration between authors and composers. This assistance is automatically granted to Canadian songwriters and composers who participated in an album or track which production was funded by Musicaction. The work must be at least 60 seconds and reproduced for the first time on a commercial medium

In 2023-2024, assistance paid on completion was \$900 per song (divided equally between lyrics and music), with a maximum of \$9,000 per project.



EMERGING ARTISTS SUPPORT - SUPPORT TO SONG PRODUCTION

This program aims to professionalize and integrate emerging artists into the music industry, by supporting the production of two to four digital titles, as well as canvassing activities. It is aimed at Canadian applicants and artists who have never recorded an album or whose work has not yet been marketed. An exception is made for artists from Canada's Francophone communities, who may have marketed a single album or digital titles.

In 2023-2024, the maximum amount awarded was \$5,000, including assistance to promote or canvass with record labels. Up to 75% of costs were eligible.


NATIONAL MARKETING

This program is intended for national marketing of a sound recording by supporting its promotion and image production for up to two years after its release (Component 1), as well as stage activities including showcases, opening acts and performances for up to 18 months after the recording's release (Component 2).

Projects accepted in 2023-2024 benefited from an exceptional measure, allowing maximum funding of up to 75% of accepted costs, or actual eligible costs, whichever was lower, up to \$15,000 for showcases, opening acts and performances, and up to \$10,000 for regional tours. Maximum funding per project for Component 1 was \$50,000, generally granted in two separate phases.

As of September 27, 2023, because of a high demand due to the resumption of activities and the music scene's great comeback, restrictive measures were implemented for 23-24.

- As general rule, for *Promotion*, funding for a first application could not exceed \$10,000 and funding for an increase could not exceed \$5,000.
- As a general rule, for *Stage*Activities, funding for a first application could not exceed \$10,000 and funding for an increase could not exceed \$5,000.
- An Applicant with an application granted under the *Promotion* component **during 23-24**, could not file another application under that component for the same album.
- An Applicant with an application granted under the Stage Activities component during 23-24, could not file another application under that component for the same album.

INTERNATIONAL MARKETING


This program is intended for international activities related to distribution and marketing of sound recordings, as well as career development of Canadian artists abroad. Restrictive measures were implemented during the year to limit the eligible territories to those of French-speaking Europe, in respect of both components:

COMPONENT 1: aims at developing and adapting artists to a target market, as well as presenting a showcase or performance to professionals with a view to building a team;

COMPONENT 2: aims to develop artists' careers through promotion and shows, when the artist or sound recording in support of the project is linked with at least one professional structure in the target market.

In 2023-2024, maximum funding for Component 1 could reach up to \$25,000, and up to 75% of costs were eligible. As for Component 2, funding was limited to \$50,000, from which funding under Component 1 was deducted where applicable, save for exceptional cases or when the conditions required for additional support were met.

Companies benefiting from the *Comprehensive Funding Envelope* program under the *Individual Initiatives* Component are not eligible to this program, except for travel for an artist's participation in an official showcase supported by the *International Event* program, or for an activity not foreseeable at the time of application to this program.








DEVELOPMENT OF ARTISTS' CAREERS, OF SKILLS AND BUSINESSES

Up to 50% of accepted costs, or actual eligible costs were admissible if lower.

SUPPORT FOR ENTREPRENEURS AND ORGANIZATIONS OF FRANCOPHONE OLMCs

COMPONENT 1 – Support for businesses

This program mainly seeks to strengthen the capacity of the music industry infrastructure within francophone minority communities to develop audiences for their francophones artists. It aims to support business structuring (including start-up), consolidation and/or diversification of activities, to advance business knowledge and skills training and reinforcement and to contribute to the creation of optimum conditions allowing sound management practices that are adapted to the needs of these businesses and the artists they represent.

For the first year of the program in 2023-2024, maximum funding could reach up to \$75,000 per business and Musicaction participation could cover up to 90% of eligible costs, save for exceptions.






COMPREHENSIVE FILING FOR COLLECTIVE INITIATIVES

This program allows to grant financial assistance once a year to an organization to undertake a series of activities that will shine a brighter light on Canadian artists and music industry professionals, develop their artistic and entrepreneurial skills and strengthen the capacity of various sectors of the Canadian music industry. This program concerns the performance of activities eligible under these programs: *Event in Canada, Music Showcases – Component 4, Professional Development, National Collective Promotion, Music Showcases – Component 2, International Event – Welcoming International Professionals,* and *Canvassing*.

Annual funding is granted based on the various activities submitted and the funding history of the organization.




EVENT IN CANADA

Stimulating the programming of Canadian artists in major French-language events in Canada to further their career development is the primary purpose of this program. Specialized music events are also eligible.

Save for events carried out by Indigenous peoples or by minority groups who are part of public priorities and policies on diversity and inclusion, events must have developed a significant professional component by offering organized professional activities.

In 2023-2024, maximum funding could reach up to \$85,000 per event for all French-language events and up to \$30,000 for specialized music events. Any newly funded event was however limited to \$15,000 for its first year of funding.

INTERNATIONAL EVENT

This program is intended for collective initiatives seeking to stimulate international career development of Canadian artists. It supports the presentation and promotion of international showcases in established export markets that are favorable to the musical genre presented. Performances must occur in front of an audience of foreign professionals. Priority is given to projects with a foreign partner or that optimize the presence of artists on the concerned territories by adding performances, business meetings or any other activity seeking to develop international markets. This program also supports collective promotion initiatives that highlight Canadian artists and their activities on foreign territories as well as welcome international professionals in Canada within Frenchlanguage music events.

In 2023-2024, maximum funding could reach up to \$60,000 per project and could not exceed 75% of approved costs or the actual eligible costs if they proved to be lower.



MUSIC SHOWCASES - CANADA'S FRANCOPHONE MINORITY COMMUNITIES

This program mainly seeks to stimulate programming of Francophone artists from official-language minority communities in major events and tours to advance their professional career development. The program also seeks to give Canadian Francophone communities access to musical performances in their language.



APPROVED PROJECTS



COMPONENT 1 – National showcases

This first component is intended to support Canadian artists hailing from Francophone minority communities and who are selected to perform an official paid or unpaid showcase before industry professionals. Exceptionally, an association or organization from a Francophone community can apply to present at a major event in Quebec a minimum of 3 artists from Canadian francophone minority communities. The same is also possible for an Anglophone event in a province other than Quebec that wishes to present a minimum of 3 artists having a similar profile.

For projects approved in 2023-2024, funding could reach up to \$4,000 per trip and could not exceed 75 % of costs. Funding could reach up to \$15,000 for projects presenting at least 3 artists that were led by an organization of the Canadian Francophonie or an Anglophone event in a province other than Quebec.

COMPONENT 2 – National tours



This second component is concerned with the professional development of artists and with improving their exposure through tours in Canada before Francophone and Anglophone audiences. Two applications must be made for each tour: one by an eligible network and the other by the artist or his or her agent.

Specific funding for digital promotion of the tour can also be approved for the network hosting the tour.

For projects approved in 2023-2024, funding could not exceed 75% of the approved costs or the actual eligible costs.

COMPONENT 3 – International Showcases and Tours

This third component seeks to stimulate programming, within foreign events offering significant exposure, of Canadian Francophone artists who generally have at least one marketed sound recording. Priority is given to trips by artists selected for an event supported by the International Event program. This component also seeks to support international tours as well as activities that will help Canadian Francophone artists develop and adapt for a target market. During the year, restrictive measures were implemented to limit eligible foreign territories to those of French-speaking Europe and to redirect tour projects to the *International Marketing* program, which only accepted trips to perform showcases before professionals.

In 2023-2024, funding could not exceed 75% of the approved costs or the actual eligible costs.



COMPONENT 4 – French-Language Music Events in Canadian Francophone Communities

This component is intended to support Canadian Francophone events that are held in provinces or territories other than Quebec and that attract a sizeable number of industry professionals and give significant exposure to artists from Canadian Francophonie communities. It is also intended to promote and stimulate the programming of Canadian Francophonie artists at major French-language music events held in Quebec.

In 2023-2024, maximum funding could reach up to \$85,000. However, any new event funded by the program could not received more that \$15,000 for its first year of funding. An additional amount of up to \$5,000 could be awarded for a specific activity seeking to promote Canadian Francophonie artists to professionals participating to an event in Quebec. Fee assistance of a maximum of \$5,000 could be sought for Canadian Francophonie artists selected for an event in Quebec as well.

Funding could not exceed 75% of approved costs or of actual eligible costs if lower.




SUPPORT MEASURE FOR PARENTS

This program provides support to performing artists who are the mother or father of a child 6 years old or under, to assist them in their national or international career development. Travel expenses for a person who is entirely dedicated to childcare during a trip are thus admissible. Such support can be applied for to cover admissible fees, i.e. costs of transportation, accommodation and per diem of the accompanying person during a trip for a showcase or a tour funded under the *Individual Initiatives* Component.

The measure was extended in 2023-2024, as a pilot project, to professional women (entrepreneurs or employees) who are traveling in a professional capacity and to women musicians accompanying an artist supported by the Canada Music Fund.

In 2023-2024, maximum support could reach up to \$3,000 per trip. Funding could not exceed 75% of approved costs or of actual eligible costs if they proved to be lower.

This program seeks to support new, one-time and innovative large-scale collective promotional activities or initiatives. These must have a conclusive impact on the development, exposure, availability or position of Canadian French-language music on domestic and digital markets and must be developed outside the usual business activities of the applicant. Exception is made for recurring collective promotion projects carried out by national, provincial or territorial associations within their usual activities, including gala events or award ceremonies.

In 2023-2024, maximum support could reach up to \$400,000 when justified by the scope of the collective promotion and the investment required. Funding could not exceed 75% of approved costs or actual eligible costs if they proved to be lower.





It provides funding for structuring initiatives and promising projects that will contribute to the development of skills as well as entrepreneurial and professional capacities through transmission of knowledge, use of expertise and personalized support, all with the intended purpose of building audiences for the Francophone artists of these communities.

For the first year of this program in 2023-2024, maximum funding could generally reach up to \$50,000 per organization, and financial participation could cover up to 100% of eligible costs.

INDEPENDENT AUDITOR'S REPORT

To the Directors of La Fondation Musicaction

Opinion

We have audited the financial statements of **La Fondation Musicaction** (the « **Organization** »), which comprise the balance sheet as at March 31, 2024, and the statements of earnings, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of **La Fondation Musicaction** as at March 31, 2024, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis of opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the **Organization's** ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the **Organization** or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Organization's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the **Organization's** internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the **Organization's** ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the **Organization** to cease to continue as a going concern.

• Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

1. STATUTES AND PURPOSE OF THE ORGANIZATION

La Fondation Musicaction was incorporated on September 9, 1985, as a non-for-profit organization without share capital, under Part II of the *Canada Business Corporations Act*. In December 2013, **La Fondation Musicaction** extended its statutes under section 211 of the *Canada Not-for-profit Corporations Act*.

La Fondation Musicaction is a not-for-profit organization whose objective is to help foster the development of music by supporting sound recording production and promotion as well as collective promotion and professional development activities. For this purpose, **La Fondation Musicaction** offers financial contribution programs to artists, recording companies, producers, publishers, managers, authors and composers, as well as to associations, organizations and events.

Under the *Income Tax Act* (Canada) and the *Taxation Act* (Quebec), **La Fondation Musicaction** is a not-for-profit organization, and therefore, is not subject to income taxes.


2. FUNDING OF THE ORGANIZATION

On April 14, 2020, a new contribution agreement for the next five (5) years was signed between the Department of Canadian Heritage and **La Fondation Musicaction** for the management of the Canada Music Fund and more specifically, for two components entitled *Individual Initiatives* and *Collective Initiatives*. This agreement provided for annual contributions of \$ 9,949,692 for 2023-2024.

It was subsequently amended on August 10, 2021, to include, among other things, an extension of the regular funding of \$ 3,840,000 for 2023-2024.

Also, as part of the *Action Plan for Official Languages 2023-2028*, an increase in the funding of Musicaction of \$ 1,000,000 annually was confirmed on January 4, 2024 for five (5) years (2023-2024, 2024-2025, 2025-2026, 2026-2027 and 2027-2028).

Finally, two additional fundings increased Musicaction's annual contribution for 2023-2024. The first one, of \$ 984,667, was ratified on February 26, 2024, while the second one, of \$ 1,923,657, was ratified on March 27, 2024.



2. FUNDING OF THE ORGANIZATION (CONTINUED)


This agreement and its amendments provide for contributions totalling \$ 17,698,016 for the year ended March 31, 2024 and \$ 10,949,692 for the year ending March 31, 2025.

According to the April 14, 2020, agreement, a portion representing 55 % to 75 % must support the *Individual Initiatives* component and a portion representing 25 % to 45 % must support the *Collective Initiatives* component over the entire duration of the agreement. In addition, a maximum of 12 % of these contributions may be allocated to the administrative, communication, audit and valuation expenses incurred by **La Fondation Musicaction**.

During the year ended March 31, 2024, **La Fondation Musicaction** also received a contribution of \$1,000,000 from *The Foundation Assisting Canadian Talent on Recordings* (FACTOR) under the Comprehensive Funding Envelope program for English-language projects.

3. SIGNIFICANT ACCOUNTING POLICIES

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO) and include the following significant accounting policies.



3. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of estimates

The preparation of these financial statements, in accordance with ASNPO, requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the current period. The most subjective estimates relate to the useful life of capital assets.

Revenue recognition

La Fondation Musicaction uses the deferral method of accounting for contributions. Contributions from the renewal of licenses are accounted on a cash basis since the Organization does not know in advance the contributions that will be paid. Nevertheless, the Organization ensures itself to have cashed the contribution due based on the radio and television broadcasters' financial year. All other contributions are accounted on an accrual basis in accordance with the amounts provided in the agreements.

Contributions from commercial radio or television broadcasting companies are an express underlying condition for obtaining and renewing their broadcast licenses with the Canadian Radio-television and Telecommunications Commission (CRTC).


In addition, when there is an acquisition of a radio broadcasting company, the CRTC asks the buyer to make contributions to organizations dedicated to the development of Canadian talents. In those circumstances, **La Fondation Musicaction** benefits from a portion of these contributions and they are accounted for as transfers of ownership or tangible benefits.

Interest income and mutual funds units' distributions are recognized as earned.

Financial instruments

Measurement of financial instruments

La Fondation Musicaction initially measures its financial assets and liabilities at fair value except for financial assets and liabilities from related party transactions which are measured at cost. They are subsequently measured at cost or amortized cost except for investments in mutual funds units which are measured at fair value. Changes in fair value are recognized in the statement of earnings.



3. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Financial contributions

All the programs offered by **La Fondation Musicaction** are in the form of financial contributions and are accounted for as an expense when the amounts have been paid.

Capital assets

Capital assets are recorded at their historical cost. Amortization is calculated using the straight-line method on the following periods:



Impairment of long-lived assets

A long-lived asset is tested for impairment whenever events or changes in circumstances indicate that its carrying amount may not be recoverable. An impairment loss is recognized when the carrying amount of the asset exceeds the sum of the undiscounted cash flows resulting from its use and eventual disposition. The impairment loss is measured at the amount by which the carrying amount of the long-lived asset exceeds its fair value.

Contributed services

Members of the Board of Directors of **La Fondation Musicaction** attend Board meetings without compensation. Due to the difficulty of determining the fair value of contributed services, they are not accounted for in the financial statements.



3. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Cash and cash equivalents

La Fondation Musicaction's policy is to disclose bank balances under cash and cash equivalents, including term deposits with a maturity period of three months or less from the date of acquisition or redeemable.

4. CAPITAL DISCLOSURES

With respect to its capital management, **La Fondation Musicaction's** objective is to preserve its ability to maintain its operations in order to continue to meet its purpose as described in Note 1, taking into account its financial resources which allow it to meet its remaining commitments and to pay financial contributions to newly submitted projects.


Except for the fact that a maximum of 12 % of the contributions received from the Department of Canadian Heritage may be allocated to administrative, communication, audit and valuation expenses, **La Fondation Musicaction** is not subject, under external rules, to capital requirements.

5. INTERNALLY RESTRICTED NET ASSETS

The Board of Directors allocated net assets in the amount of \$ 2,605,513 (\$ 3,411,457 in 2023) in order to cover the payment of commitments related to financial contributions for which **La Fondation Musicaction** was committed as at March 31, 2024, and to provide for administrative expenses related to the monitoring and settlement of these commitments.





10. RELATED PARTY TRANSACTIONS

La Fondation Musicaction paid financial contributions to related companies totalling \$2,479,530 (\$2,486,152 in 2023). The parties are related since their representatives are directors of **La Fondation Musicaction**. These related companies satisfy all of the criteria established by **La Fondation Musicaction**, and as such, they do not benefit from any special status or privilege due to their representation on the Board of Directors.

Management is of the opinion that these transactions were concluded under the same terms and conditions as transactions with other applicants, and they are measured at the exchange amount.



11. COMMITMENTS

Financial contributions

As at March 31, 2024, **La Fondation Musicaction** has a remaining balance of commitments totalling \$ 2,292,851 (\$ 3,003,282 in 2023). Of this balance, an amount of \$ 324,058 (\$ 286,105 in 2023) represents commitments with related companies. In order to achieve its commitments, **La Fondation Musicaction** will incur administrative expenses of a maximum of 12 %.

12. FINANCIAL INSTRUMENTS

Credit risk


Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. **La Fondation Musicaction's** main credit risks relate to its contribution's receivable from music services and satellite radio broadcasting companies and trade receivables.

Liquidity risk

Liquidity risk is the risk that the **Fondation** will have difficulties to honor commitments related to its financial liabilities. The **Fondation** is exposed to this risk mainly with respect to its trade payables and its accrued salaries.

Interest rate risk

La Fondation Musicaction is exposed to interest rate risk regarding its financial instruments with fixed interest rates. Fixed-rate instruments subject **La Fondation Musicaction** to a fair value risk. As at March 31, 2024, **La Fondation Musicaction** holds fixed-rate term deposits, guaranteed investment certificate, bonds and capital shares.



12. FINANCIAL INSTRUMENTS (CONTINUED)

Other price risk

Other price risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices (other than those arising from interest rate risk) whether those changes are caused by factors specific to the individual financial instrument or its issuer, or by factors affecting all similar financial instruments traded in the market. **La Fondation Musicaction** is exposed to other price risk through its investments in mutual funds units.

13. PENSION PLAN

La Fondation Musicaction has a defined contribution pension plan for all its employees. Contributions to the pension plan represent 7 % of the basic salary and are subject to the employee's voluntary contribution of 3.5 %. The pension plan cost of \$ 107,003 (\$ 102,548 in 2023) is included in salaries and fringe benefits.
